***Motion by Councilmember Fleming to approve \$1500 to be paid from Food & Beverage for Boys & Girls Club van, 2<sup>nd</sup> by Councilmember Robertson. Councilmember Kutz abstains. Motion carries by a majority vote.***

**Food & Beverage Request – Lincoln Day to sponsor a hospital at the event.**

***Motion by Councilmember Fleming to approve \$1500 to be paid from Food & Beverage for hospital at Lincoln Day event, 2<sup>nd</sup> by Councilmember Kincaid. Motion carries by a unanimous vote.***

**Food & Beverage Request – Back to the 50's Event Carmen Ottinger asks for \$1500 for Sound Tech Co. and food court electricity.**

***Motion by Councilmember Fleming to approve \$1500 for Back to the 50's Event, 2<sup>nd</sup> by Councilmember Robertson. Kutz votes nay. Motion carries by a majority vote.***

**Food & Beverage Request – Boone County Mentoring – Tabled - as no one was present.**
